Whatever you decide is the best way for you to contribute in your community – Thank You! And keep up the good work in 2021!





Tom developed the MyGemba Improvement Management Software system approximately 20 years ago to help others effectively train, manage, and track process improvement projects so that 5S, KAIZEN, LEAN, Toyota Kota, Six Sigma, etc. are all managed in one place.

Marty Abbott has over 15 years of company experience and over 30 years' experience providing services to corporations. Most recently, he has been leading a premier services organization negotiating incentives for corporations to enhance capital investment ROI and improving skills development to achieve business goals as President and Founder of Incentives Management Group, Inc.



Agile Approach to Lean Six Sigma

Lean Six Sigma, Data Analysis, Excel and TQM Expert

Faced with continuous, accelerating, disruptive change, businesses have had to find innovative ways to respond. Surprisingly, they found a faster, better, cheaper path in Information Technologies (IT) of all places. Yet Lean Six Sigma is anything but agile. Spending months training Black and Green Belts and then waiting months or years for results is no longer acceptable. This might have been possible in the last century, but it won't work for 21st century quality.

We need to adapt Agile to Lean Six Sigma. Unfortunately, the old trial-and-error, gut-feel approaches to improving performance are too slow and error-prone to deliver anything close to perfection. The only hope any business has is to adopt the methods and tools of Lean Six Sigma to simplify, streamline and optimize performance. Lean Six Sigma can be fast, affordable and flawless, maximizing results while minimizing costs.

In this presentation, Jay will focus on tools needed to achieve results.

Companies don't need more Green Belts or Black Belts. They need more Money Belts—people who can quickly find ways to save time and money to boost productivity and profitability. Lean Six Sigma needs to pivot to a new way of achieving desired results. Integrating Agile into Lean Six Sigma is an easy way to do it. What is Agile? A method that is characterized by the division of tasks into short phrases of work and frequent reassessment and adaptation of plans. Agile focuses on speed and adaptability, not rigid adherence to archaic methods.

Is it possible to accelerate the adoption and use of Lean Six Sigma by hacking how it's implemented? Absolutely.

About the speaker: Jay Arthur was trained in the Deming Award Winning Florida Power and Light improvement process in 1990. He has worked as both a quality and process manager within a Fortune 50 company and on his own as a Six Sigma resultant. Jay is the author of numerous books, including *Lean Six Sigma Demystified*, *Lean Six Sigma for Hospitals*, *Agile Process Innovation: Hacking Lean Six Sigma to Maximize Results*, and *QI Macros Lean Six Sigma Software for Excel—a software package that automates all of the charts, graphs, and documents required for quality improvement*.

ASQ CERTIFICATION EXAMS CONTINUE DURING PANDEMIC

If you have been thinking about applying for an ASQ Certification, but have hesitated because of the pandemic, ASQ and Prometric Testing Centers have you covered! Because of the extended closure of most of their testing centers, Prometric now offers ProProctor, an online proctored testing option. This is very similar to taking the exam at a computer testing center, except that you take the exam from home (or work) while being proctored remotely via your microphone and webcam.

This testing option is officially available only through December 31 - but it will likely be extended as long as the nearby Prometric exam centers remain closed. This can only be done by appointment, and time slots are in high demand. Also, due to potential quarantine restrictions affecting the ability to renew IDs, Prometric is temporarily accepting expired government IDs, but only if they expired *after* February 1, 2020. Applications are now being accepted for exams scheduled for January 1-31, 2021. The application deadline is December 4 for the following certifications:

- CQT (Quality Technician)
- CQI (Quality Inspector)
- CRE (Reliability Engineer)
- CFSQA (Food Safety and Quality Auditor)
- CMDA (Medical Device Auditor)
- CMQ/OE (Manager of Quality/Organizational Excellence)
- CSSBB (Six Sigma Black Belt)
- CSSYB (Six Sigma Yellow Belt)
- CSQP (Supplier Quality Professional)

The next set of exams will take place February 1-28, 2021. The application deadline for the following exams is January 4, 2021:

- CQA (Quality Auditor)
- CQE (Quality Engineer)
- CQIA (Quality Improvement Associate)
- CSQE (Software Quality Engineer)
- CSSGB (Six Sigma Green Belt)
- CQPA (Quality Process Analyst)
- CCT (Calibration Technician)
- CPGP (Pharmaceutical GMP Professional)

The recertification process is unchanged. Be sure to keep your online Recertification Journal updated as you complete qualifying activities that earn Recertification Units (RUs). Remember that while you have a 6 month "grace period" following your recertification date to submit your Journal, you can only claim RUs that were earned during your three-year certification period.

Women account for nearly half of the U.S. labor force and hold approximately 50 percent of all management and professional-level jobs. However, American women lag substantially behind men in leadership positions, filling only 6% of the CEO roles at S&P 500 companies. Over the past five years, however, the number of women in corporate senior leadership has grown, and the watershed congressional election of 2018 saw a record 117 women voted into public office. The conversation around redefining professional success and changing how corporations choose leaders is getting louder, with more women adding their voices to the discussion.


PERFORMANCE IMPROVEMENT DURING A TIME OF SURVIVAL
