Why Lean Transformations Fail and What to do About it

Founder and Chief Executive Officer Lean Horizons Consulting, LLC

With 30 years of driving Lean transformations under his belt - both in-house at Danaher and as the founder of Lean Horizons - Mark has a vantage point across a variety of industries that most of us don't have. He often hears about the many challenges Lean leaders face now that they've been implementing Lean for a decade or more. They are concerned that they are not getting the results they used to, and they don't know why that is.

Most leaders believe their problems are unique to their own organization or company, but Mark sees more commonalities than differences. His book, *Flatlined: Why Lean Transformations Fail and What to Do About It,* draws on his experience as the original pioneer of the most successful Lean business system next to Toyota, as well as his progress over the past 18 years in helping numerous companies replicate what Danaher achieved.

To make rapid shifts, you need an actionable approach, not just theory. The presentation will include some ideas for action (from Mark's book) and will also cover lessons learned from his association with hundreds of Lean transformations on a global basis.

<u>About the speaker:</u> Mark DeLuzio is Founder and Chief Executive Officer of Lean Horizons Consulting, LLC. He is a former Corporate Officer and Vice President of Danaher Business System (DBS) for Danaher Corporation (NYSE: DHR), where he was the principal architect of DBS, deploying it on a global basis. Mark holds two undergraduate degrees in business (Marketing and Accounting) from Central Connecticut State University, and an MBA in Operations Management from the University of Hartford. He also holds a Certificate in Production and Inventory Management (CPIM) and is a Certified Management Accountant (CMA).

In 2007, Mark was inducted as a Life Member of the Shingo Prize Academy (Lean Hall of Fame) for his lifetime contribution to "Excellence in Manufacturing." He has appeared on numerous podcasts for his business experience and lessons in overcoming life's setbacks. In addition to numerous white papers and magazine articles, Mark is the author of "Turn Waste into Wealth," which offers practical advice for those considering a Lean transformation.


