#### Will You Pass the Grocery Store Test in 2023?

Years ago, a friend told me she wasn't one to burn bridges. If she ever bumps into a customer or colleague at the grocery store, she doesn't want them to try to avoid her.

I've tried to take her idea to heart. I envision a future day, 15 or 20 years down the road, when I'm pushing a cart down the cereal aisle, and I spot a former business acquaintance selecting a box of Cap'n Crunch from the shelf.

The person then sees me and, instead of spinning on her heels or simply giving me a head nod "hello,' a smile appears on her face. She approaches my cart and engages me in a bit of small talk. I leave feeling better about myself, glad I took my friend's advice all those years earlier. Content that I hadn't burned a bridge.

I've learned that the difference between burning bridges and shutting doors involves more than just how nicely I deliver the 'no.' While burning bridges leaves relationships in tatters and opportunities destroyed, closing doors merely says, "I appreciate the opportunity, but the fit isn't great right now. But let's keep the conversation moving if possible."

The surprising thing is that although my mind shifted from burning bridges to shutting doors, I've realized that effectively closing a door involves a strong understanding of my priorities and the perspective of the person who offered the open door in the first place. If I want to maintain that relationship, I need to do more than say, "thanks but no thanks."

Saying 'no' to an opportunity brings baggage with it. The other person may be offended; no matter how gracious I am, they are still dealing with rejection. Processing rejection takes time, and I need to allow the person to do so. I may have said 'no,' but they still need their issues addressed.

One of the best ways to turn a potentially burned bridge into a nicely shut door is to help the other person find someone who can meet their needs. By doing so, we are holding it open for someone else instead of closing the door completely.

## Quality in Integrated Product Development using APQP

Advanced product quality planning (APQP) is a process developed in the late 1980s by a commission of experts who gathered around the 'Big Three' of the U.S. automobile industry: Ford, GM, and Chrysler. Representatives from the three automotive original equipment manufacturers and the Automotive Division of the American Society for Quality Control (ASQC at the time) created the Supplier Quality Requirement Task Force to develop a common understanding on topics of mutual interest within the automotive industry.

This commission worked for five years to analyze the then-current automotive development and production status in the U.S., Europe, and especially in Japan, because they were so successful in the market. APQP then spread to the aerospace industry because it assures that the needs of the customer are clearly understood and translated into clear technical requirements.

Join us on March 8 to discuss APQP. This is a structured, stage-gate process aimed at ensuring customer satisfaction for new products being developed. Because it is a highly proactive product development process, it also ensures that companies fully integrate their design, development, and manufacturing processes from concept to product use, service, and customer feedback.

<u>About the speaker:</u> Eliot Dratch is the Lead for CMTC's Quality Practice, specializing in quality, lean, and safety improvements for medical and aerospace companies. He applies 25 years of industrial manufacturing experience to add value to an organization's P&L. #### ASQ CERTIFICATION EXAMS

Did you know that In 2022 five of ASQ's certification programs achieved ISO 17024 Accreditation through the ANSI National Accreditation Board (ANAB)? ANAB is the largest multi-disciplinary accreditation body in the western hemisphere, with more

than 2,500 organizations accredited in approximately 80 countries. Federal, state, and local authorities rely on ANAB accreditation to demonstrate value and assure competency for important public priorities.

ASQ Certifications are recognized as a mark of quality excellence in many industries. It is important to understand that certification is not a license or registration. It is peer recognition that an individual has demonstrated proficiency in, and comprehension of, a particular quality area at a specific point in time.

ASQ certification is awarded to those who meet the three criteria below:

- 1) Have a specified level of education and/or experience
- 2) Provide proof of professionalism
- 3) Pass a standardized exam in the certification area

Applications are now being accepted for ASQ Certification exams scheduled May 1-31, 2023. The application deadline is April 9 for the following certifications:



## MAKING MISTAKES AND "FAILING" IS A GOOD THING

Making mistakes and "failing" is a good thing. That's how we learn and progress. Not from textbooks or hearsay. It takes the right mindset and company culture though:

As Arianna Huffington has said, "We need to accept that we won't always make the right decisions, that we'll screw up royally sometimes - understanding that failure is not the opposite of success, it's part of success."

That's how we embrace failure!

On the other side, there exists in many companies a "blame culture" where mistakes and failure are not allowed. Worse, they're usually hidden. The fear to be punished makes managers and employees wish for an easier life, a better position where they'll be less at risk, for less effort. The mantra is, "In case of a failure just blame others instead of trying to help fix things." As a result, either the initiative dies of lack of momentum, or managers/teams enter into the political game. Unfortunately, being a politician means that they become pretty much useless to organizations that want to perform and succeed.

Then there are leading organizations that consider failures and mistakes as learning opportunities, as a chance to evolve more quickly and in a more innovative way. They encourage failure, rely on thinking outside the box, and allow employees to make mistakes and see what happens. Learning and adapting is the preached mantra. Most importantly, they not only talk about the culture of failure, but they put it every day into practice by creating the right environment, leadership, and systems.

They celebrate contributors who are quick to identify and correct issues because they know that identifying problems helps the business succeed faster. In addition, and that's a major differentiator to "blame" organizations, they have created processes to follow through in a systematic manner once failures are identified.

A final powerful reminder of thought leader Tom Krause: "There are no failures–just experiences and your reactions to them."
